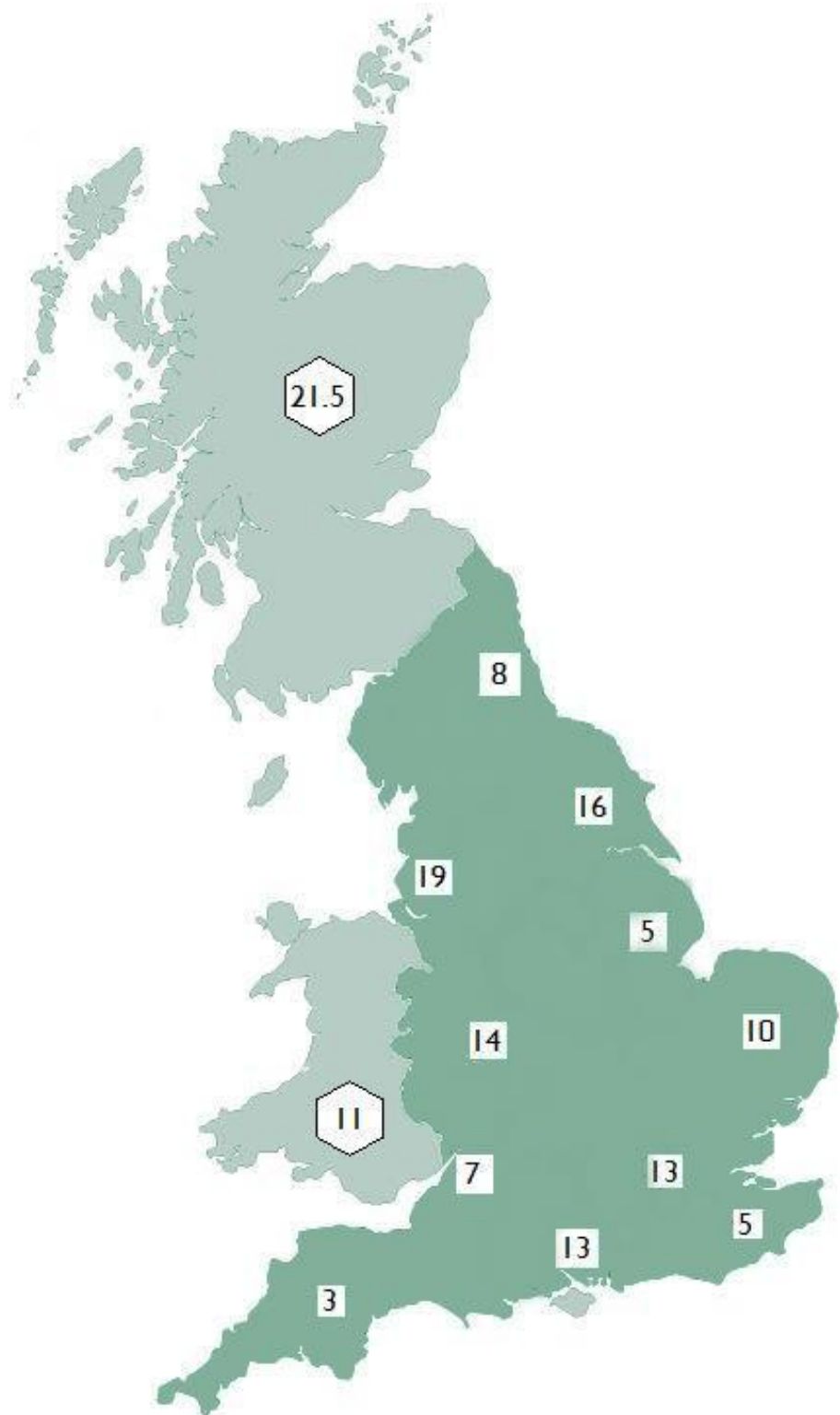


BBC Local Democracy Reporter allocation
