

# BBC Radio Lancashire Let's Get Lyrical Telephony Competition Terms and Conditions and Privacy Notice

## PRIVACY NOTICE

Your trust is very important to us. This means the BBC is committed to protecting the privacy and security of your personal data. It is important that you read this notice so that you are aware of how and why we are using such personal data. This privacy notice describes how we collect and use personal data about you during and after your relationship with us, in accordance with data protection law.

### **Why are we doing this and how can you participate?**

The "Let's Get Lyrical Competition" will be played during the Breakfast Show on BBC Radio Lancashire between Monday and Friday.

The presenter will give a qualifying question during the Breakfast Show, and you have until 8.30am to call in with your answer.

The winner will be randomly selected from those that have answered the qualifying question correctly.

A member of the production team will call the winner back, so they can be put live on-air to take part in the main competition which is based around a song and lyrics. The presenter will play a section of a song and when it stops the caller will be asked to sing or say the next word. The next word they say will be taken as the answer. If the caller gets it right, they will be the winner of a pair of BBC Radio Lancashire Odd Socks!

If we broadcast your contribution on-air, this may include the programme being available online and/or on demand, and your contribution may be used again in a future broadcast.

### **What personal data will BBC collect and how will we use it?**

If you get the qualifying question right the BBC will collect your personal data for the purposes of administrating "The Let's Get Lyrical Competition".

### **Personal data:**

You must be 18 or over to take part in the competition.

The BBC will collect and process the following **personal data** about you:

- Your full name
- Your phone number

If you are a winner, we will ask for your postal address so that we can send you the prize.

### **Who is the Data Controller?**

The BBC is the "data controller" of your personal data. This means that the BBC decides what your personal data is used for, and the ways in which it is processed. For the avoidance of doubt, your personal data will be collected and processed solely for the purposes set out in this privacy notice. As the data controller, the BBC has the responsibility to comply, and to demonstrate compliance with, data protection law.

### **Lawful basis for processing your personal data**

The lawful basis on which the BBC processes the personal data **is the performance of its public task**. The BBC's role is to act in the public interest and to serve all audiences with content which

informs, educates and entertains, and to reflect the United Kingdom and its cultures and values to the world.

### **Sharing your personal data**

The BBC works with our approved third-party providers who help us to provide some of our services. These partners only use your personal data on behalf of the BBC and not independently of the BBC.

We may share personal data with a third-party where required or permitted by law.

### **Retaining your personal data**

Unsuccessful participants personal data will be deleted within 24 hours.

If you are a winner, the BBC will retain your personal data for a period of two (2) years for regulatory reasons, after which it will be deleted.

If your contribution is used for broadcast, your personal data will be retained and archived in perpetuity by the BBC.

Your personal data will be stored in the UK.

### **Your rights and more information**

You have **rights** under data protection law:

- You can **request a copy** of the personal data BBC stores about you.
- If your personal data is inaccurate, you have the right to have the data **rectified**.
- You have the right to ask for the personal data we collect about you to be **deleted** however there are limitations and exceptions to this right which may entitle the BBC to refuse your request.
- In certain circumstances, you have the right to **restrict** the processing of your personal data or to **object** to the processing of your personal data.
- You have the right to ask that we **transfer** the personal data to you or to another organisation, in certain circumstances.

### TERMS AND CONDITIONS

1. The competition is open to all residents of the UK, including the Channel Islands and the Isle of Man, aged 18 or over, except BBC or BBC Group company employees and anyone connected with the competition. Proof of age and eligibility may be requested.
2. The competition will be played during the BBC Radio Lancashire weekday breakfast programme from Monday to Friday (except when editorial requirements lead to a change in schedule or a change in programme content).
3. During each programme, listeners will be invited to call in and register to play by correctly answering a qualifying question. Lines will open at around 07:20 but will vary so please listen to announcements during the programme. Lines will close at 08:30
4. Listeners can enter by calling 0800 78 33 583 - calls are free from landlines and mobiles. You may enter once per day – any additional entries will not count.
5. One contestant will be selected at random from those who correctly answer the qualifying question. A member of the production team will call them back so they can play the live on-air quiz at around 08:50.
6. The contestant will then be played a part of a song and they will need to sing or say the next word in the lyric when the song ends. If they guess the next word correctly they will win a pair of BBC Radio Lancashire Odd Socks.
7. Entrants must ensure that they are available on the telephone number provided to take the call from the production team if they are selected to play. If an entrant is not available after three attempts by the production team, another correct entrant will be randomly selected.
8. The prize is a pair of BBC Radio Lancashire Odd Socks. There is no cash alternative and the prize cannot be sold or transferred in any circumstances.
9. The BBC's decision as to prizes awarded is final. No correspondence relating to the competition will be entered into.
10. In the event of the production team receiving no entries for the qualifying question the producer will reserve the right to change or amend the question within a reasonable timescale so as to leave enough time for people to enter.
11. The BBC reserves the right to: (i) amend these terms and conditions; (ii) disqualify any entrant who breaches the rules, has acted fraudulently in any way or brings the BBC into disrepute; and (iii) disqualify an entrant or winner, withdraw or substitute any prize, should any entrant or winner at any stage exhibit inappropriate or dangerous behaviour (including, but not limited to being under the influence of alcohol, chemical substances or causing a nuisance).
12. Entrants will be invited to take part in any post-competition publicity.
13. Entrants will be deemed to have accepted these terms and to agree to be bound by them when registering.
